WHEREAS, School Board and **Agency** entered into that certain Agreement for educational services dated May 22, 2012; and

WHEREAS, the parties desire to amend that Agreement with this document.

NOW, THEREFORE, the parties hereto amend the Agreement as follows:

3. Except as herein expressly modified, the Agreement for educational services dated May 22, 2012 shall otherwise remain in full force and effect, subject to all terms and conditions therein.
