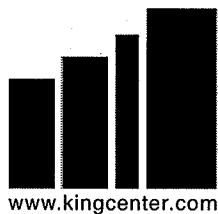

The Maxwell C. King Center for the Performing Arts, Inc. and Brevard County Public School District made and entered into this agreement for School Board of Brevard County Public School District to purchase the production of 1776 in cooperation with The Cocoa Village Playhouse for the intended purpose of creating and arts experience for 11<sup>th</sup> grade students of Brevard County Public School District as outlined.

**Program:** The producer Cocoa Village Playhouse under the direction of Anastasia Hawkins-Smith understands the production of 1776 will be presented in the professional and customary full length format.

**Program date(s) & time:** Monday, Tuesday, Thursday and Friday April 20, 21,23 and 24, 2009 one (1) performance each date beginning at 10:00 AM and one (1) additional performance at 7PM on Monday for Brevard Public School staff and faculty for a total of five (5) performances and 500 tickets for Tuesday evening at best available location. The number of outreach sessions will be determined and finalized with the producer and the school district.

**Compensation:** School Board of Brevard County Public School District agrees to pay a flat guarantee fee of \$40,000 for the shows as outlined. The total fee is inclusive of production costs, stage hands, and house costs. House costs include, but not limited to: custodial, parking/security, catering, and house staff. Payment to the Maxwell C. King Center for the Performing Arts, Inc. as follows: Balanced of \$40,000 is due by Friday May 8, 2009. An invoice is enclosed for your convenience.

**Indemnification & Insurance:** Maxwell C. King Center for the Performing Arts, Inc. agrees to indemnify and hold Brevard County Public School District harmless from and against any and all liability claims of bodily injury or property damage, including reasonable attorney fees, in connection with or arising out of operations of the Maxwell C. King Center premises or any negligence or willful misconduct of Maxwell C. King Center, its agents, employees or contractors. 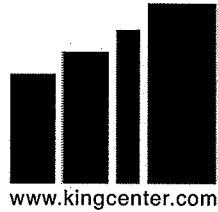
