

COOPERATIVE AGREEMENT

BETWEEN  
THE SCHOOL BOARD OF Brevard County, FLORIDA  
AND  
RECORDING FOR THE BLIND AND DYSLEXIC

THIS AGREEMENT entered into this \_\_\_\_ day of May 2009, by and between RECORDING FOR THE BLIND AND DYSLEXIC, a nonprofit volunteer organization hereinafter referred to as "RFB&D" and THE SCHOOL BOARD OF BREVARD COUNTY, a public body corporate, hereinafter referred to as "THE BOARD".

WITNESSETH

WHEREAS both parties mutually agree to maintain a cooperative contractual relationship for the purpose of preserving the present quality and unique contribution of RFB&D and Brevard County Public Schools, the parties have agreed as follows:

- I. Terms of Agreement: This Agreement shall be effective July 1, 2009 through June 30, 2010. Either party may terminate the Agreement before June 30, 2010 by giving sixty (60) days written notice to the other party.
- II. During the term of the Agreement RFB&D will:
  1. Designate a coordinator to serve as liaison with THE BOARD'S Exceptional Student Education (ESE) district office.
  2. Provide orientation to school staffs prior to initiation of the program at the schools and as the need arises.
  3. Arrange for recorded books and equipment, as requested by school staffs.
  4. Furnish accident and liability insurance coverage for RFB&D staff.
- III. During the terms of the Agreement the Board will:
  1. Designate a coordinator to serve as liaison with RFB&D.
  2. Notify school principals of the contract and services to be provided.

- IV. The contract will provide for Annual Institutional Memberships at Level 1, with an annual fee of \$350 per school and a limit of 25 recorded books per year; and Level 2 with an annual fee of \$500, with a limit of 50 recorded books per year, and Level 3 membership with a annual fee of \$950, with a limit of 100 recorded books per year. The fees for services, memberships and equipment provided by RFB&D are not to exceed: \$ 49,550
- V. Payment will be made by THE BOARD'S Accounts Payable Department according to monthly billing by RFB&D.
- VI. RFB&D is an independent contractor and is not a partner with the Board. Each party employs its own personnel to perform this agreement and will compensate them as appropriate.
- VII. Civil Rights

The parties hereto agree not to discriminate against RFB&D or staff personnel because of race, creed, sex, age, national origin, or political affiliation.
